### About Essex and Suffolk Rivers Trust

### The Organisation

Essex and Suffolk Rivers Trust (ESRT) is an independent environmental charity set up in 2013 dedicated to improving and protecting rivers in Essex and Suffolk, making them a better place for people and wildlife.

We work with farmers, residents and organisations to provide advice and resources for their communities. We bring together the people, knowledge, data and intelligence to take action to help our rivers thrive again.

We are a proud member of the <u>Rivers Trust</u> movement the umbrella organisation which works across the UK and Ireland leading a movement for change in our rivers.

#### Our Vision

In Essex and Suffolk, only 10% of river stretches in the rivers and estuaries we work in are reported to be at good ecological status. This is the result of historic changes to the rivers, pollution and climate change. Our region is one of the driest and hottest parts of the country with rainfall by 2040 predicted by the Met Office to be significantly below the national average. We are increasingly affected by flooding from extreme rainfall events. Many of our key species are threatened through habitat loss and climate change.

On the positive side, we have some of the most iconic rivers and internationally important estuaries in the UK. Most importantly people who live and work near them care about their future.

Our Vision is that the rivers and estuaries of Essex and Suffolk are rich in wildlife, loved and cared for by local people and protected for future generations.

### **Our Strategy**

Our strategy to 2030 is to work with partners and communities in four areas to: Restore natural processes; Look after land and water; Inspire people to get involved and Build resilience for future generations.

Our projects and work areas are developed in service of our strategy which will deliver for people and wildlife across the waterways we look after.

#### **About This Role**

This role will lead the delivery of the <u>Recovering the Deben from Source to Sea</u> programme development phase. In 2023, the East Suffolk Catchment Partnership developed the Recovering the Deben initiative to work across the whole catchment and estuary from the source of the River Deben upstream of Debenham to Woodbridge and continuing to the sea at Felixstowe Ferry.

An Action Plan was put together and we are in the development phase of the project scoping with the aim of developing a detailed action plan for the delivery phase (2026-2030). This role will lead the development phase finishing in summer 2026.

Five workstreams have been established to focus development work in response to the objectives set out in the Action Plan. This role will coordinate the activity across five workstreams and deliver some of the development studies and activities already funded by the Water Restoration Fund.

The role will use expertise, experience and commitment to work in partnership with many stakeholder organisations and groups to make a real difference in helping to solve the complex problems of river restoration and water management in the River Deben.

## **Job Description**

Post title: Recovering the Deben Programme Manager

**Function:** To manage the Recovering the Deben from Source to Sea development phase programme of works, administer the Water Restoration Fund development funding and co-ordinate workstream activity reporting to the Steering Group.

**Responsible for:** Programme management and administration of the Recovering the Deben from Source to Sea Initiative.

### **Employment Terms**

**Term:** 12-month initial term (with intention to extend to the five-year delivery phase subject to funding). Ideal start date is the 9<sup>th</sup> June subject to discussion.

**Hours:** Full time (37.5 hours per week). Part time hours considered.

**Salary:** £37,500

Holidays: 25 days plus statutory holidays

**Place of work:** Based in our Stowmarket office, with flexible home working. Regular travel throughout the Deben Catchment

### Working Relationships

**Internal:** ESRT Director, Natural Rivers Manager, Bluespaces Manager, Project Support Officer, Volunteer and Corporate Events Officer, Blue Spaces Assistant and the Operations Support Officer

**External:** A wide range of stakeholders and partners, including the Environment Agency, Farm Clusters, Water Companies, Local Authorities, Natural England, Natural Landscapes, project funders, landowners, other NGOs and local interest groups and communities.

### Purpose of Post

To lead delivery and support the completion of the Recovering the Deben Source to Sea delivery plan which will document costed recovery actions to 2030. The role will also project manage the deliverables within the Water Restoration Fund grant, which will include a feasibility study for the alleviation of barriers to fish migration, pilot study investigations for nutrient attenuation in the estuary and investigations on the feasibility of super buffers strips within the Deben catchment. These projects will be delivered by external consultants and project partners.

### Main Responsibilities

#### **Programme and Project Management**

- Co-ordinate the delivery of development work in each of the five workstreams, working with workstream leads and reporting to the steering group.
- Organise and manage regular steering group meetings and ensure communication with the steering group for the project is clear and regular.
- 3. Oversee the regular update of the website, including updating the action plan to reflect activity completed so far in the programme and what is planned for the remaining development phase.
- 4. Project Manage three Water Restoration Fund projects working with consultants, ensuring the projects are delivered to budget and within any time constraint of the funding.
- 5. Draft reports required by the funders to meet the funding providers requirements.

- 6. Work with partners to develop new project deliverables and to seek funding opportunities to build and support the work happen already within the catchment.
- 7. Work with our Volunteer and Community Involvement Officer to support events within the local community and to produce supportive information for the work being developed or delivered.
- 8. Work with staff within the ESRT to maintain the Recovering the Deben webpages and to ensure content is regularly updated with project and partner news items.
- 9. Produce the costed activity plan.

#### **General Duties**

- 1. Uphold the values and ethos of ESRT and represent the organisation as and when required in a range of settings.
- 2. Manage individual workload and make day to day decisions as to where best to allocate your time, to satisfy the requirements of your work programme.
- 3. Ensure that ESRT policies and procedures, including Health and Safety, are always understood, and adhered to.
